An Ordinance Amending Town Ordinance No: 2013-04 To Lower Speed Limit on Town Highway

The Town Board of the Town of Sumner, Barron County, Wisconsin does ordain as follows:

SECTION I. PURPOSE

The purpose of this ordinance amendment is to reduce or modify speed limits on additional Town of Sumner town highways as follows:

SECTION II. AMENDMENT

Section A is amended as shown on the attached exhibit (added language is underlined):

SECTION III. SEVERABILITY

If any provision of this Ordinance or any application of this Ordinance to any person or circumstance is found to be invalid or unconstitutional, such a finding shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provisions or applications.

SECTION IV. EFFECTIVE DATE

This Ordinance shall take effect on August , 2016.

Amended July 12, 2016

The Town Board of the Town of Sumner, Barron County, Wisconsin, has the specific authority under s. [349.11](#), Wis. stats., to adopt this ordinance.

This ordinance, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, provides for the reduction of the speed limits on certain town highways in the town as follows:

A. Pursuant to s. [349.11](#), Wis. stats., effective December 1, 2013, speed limits on certain Town of Sumner town highways are reduced or modified as follows:

1. The speed limit on 15 ½ - 16th Avenue starting at 24½ Street (CTH M) and ending at 30th Street (County Line Road) shall be reduced to 45 miles per hour.
2. The speed limit on 30th Street (County Line Road) starting at US8 and ending at 12th Avenue shall be reduced to 45 miles per hour.
3. The speed limit on 27th Street starting at 16th Avenue and ending at USH 8 shall be reduced to 45 miles per hour.
4. The speed limit on 27th Street from USH 8 and ending at 12th Avenue shall be reduced to 45 miles per hour.
5. The speed limit on 15¼ Avenue starting at the Stanley Town Line and ending at 24½ Street (CTH M), 24 1/8 Avenue starting at 14¾ Avenue and ending at 15¼ Avenue, and 14¾ Ave starting at the Stanley Town Line and ending at 24½ Street (CTH M) in the Village of Canton are reduced to 25 mph.

B. Pursuant to s. [349.11 \(5\)](#), Wis. stats., the town chairperson, or his or her designee, shall place appropriate traffic signs at the above-described locations on or before the effective date of this ordinance.

C. No person may operate any vehicle on the above-noted town highways in violation of the above-noted speed limits. Any violation shall be subject to penalties under s. [346.60](#), Wis. stats.

This ordinance is effective on December 1, 2013.

The town clerk shall properly post or publish this ordinance as required under s. [60.80](#), Wis. stats.
