

**Town of Sumner
Town Board Meeting
Town Hall, 1550 24½ Street, Town of Sumner, Wisconsin
Tuesday, August 13, 2019**

The meeting was called to order by Town Board Chair Steven Palmquist at 7:00 p.m. Present: Supervisors Steve Becker, Kevin Crotteau; Clerk Sandra Tomczak, Treasurer Jenn Harder and patrolman David Etlicher.

Clerk verified proper public notice. Moved by Crotteau/Becker to approve the agenda. No negative vote. Reports given by Treasurer, Clerk and Patrolman. Moved by Becker/Crotteau to approve the minutes of July 9, 2019 regular meeting. No negative vote.

Public Comment. Laura Roux: favors a debris collection site for anytime it is needed. Tim Peterson: a 4-wheeler operator wrongly accused Tim of making a complaint about him to the town board.

Plan Commission Chair Jay Olson reported plan commission recommendation to approve Wentworth request to rezone. Moved Becker/Crotteau to grant the request to rezone 74.92 acres, parcels 046-0600-06-000 and 046-0600-06-000 from Ag 2 to Ag 1. No negative vote.

Amendment of ATV/UTV Ordinance discussed. A new ordinance replacing the current ordinance will be drafted and considered at the September meeting.

Log pile removal in 26th Street road right-of-way is in progress by the property owner, Tim Peterson. Logs are sold, the logs on north side of driveway are removed, south side is ¼ – 1/3 done. Will be complete possible w/n a month. Board is satisfied with the progress.

Moved Crotteau/Becker to send a bill to Jeff Antczak for road damage to 16th Avenue. No negative vote.

Becker reported on progress to make diesel fuel shed improvements. Three companies plan to bid for some of the work. Town will be able to do some of the minor work. State registration is required for the tank. State inspector is willing to overlook the completion deadline as long as progress is made. Bids will be opened at a future meeting.

Storm debris drop-off location for residents: possible problems with garbage being dropped off, no room at this time. A location will be decided on a case by case basis when there is a storm.

Recommended repairs to F350 truck will be discussed further in September.

Board received cost information from Etlicher for purchases of a “claw” and augur for the backhoe. After board has time to review the information it will be considered at the September meeting.

Suggested agenda items for next meeting: ATV/UTV Ordinance to open all town roads for ATV/UTV travel and change speed limits, consider bids (steel structure) for diesel fuel shed improvements to meet state codes and other work, recommended repairs to F-350 truck,

Moved by Becker/Crotteau to approve the payment of bills. (Report filed:checks 10957-10976) No negative vote.
