Letter sent to property owners with tax statements discussed.

Moved Becker/Crotteau to grant Town Clerk full authority to assure to Town's compliance with the Wisconsin Elections Commission's Election Security standards. Motion carried without negative vote.

Clerk presented a draft of the required election day operations emergency plan for board comment.

Moved by Becker/Crotteau to approve resolution 2019-04 for 2019 Budget Adjustment of \$500. Motion carried without negative vote.
