

**Town of Sumner  
Town Board Meeting  
Town Hall, 1550 24½ Street, Town of Sumner, Wisconsin  
Tuesday, September 8, 2020 7:00 p.m.**

The meeting was called to order by Town Board Chair Steven Palmquist. Present: Supervisor Steve Becker, Clerk Sandra Tomczak, Treasurer and Jenn Harder.

Clerk verified proper public notice. Moved by Becker/Palmquist to approve the agenda. No negative vote. Reports given by Treasurer and Clerk. Becker brought up the issue of shouldering along the new blacktop in Canton; homeowner could decide whether they want black dirt or gravel. Moved by Palmquist/Becker to approve consent agenda: a) Minutes of August 2020 regular meeting and acknowledgment that a petition from CSP Property Holdings to close the north 2560 foot portion of 26 ½ Street south from US Highway 8. No negative vote.

Verbal claim by Marge Mujwid of excessive 2019 assessment. Mrs. Mujwid presented her claim that property was incorrectly assessed as "Undeveloped", not as "Ag Use". The verbal claim was made at the beginning of August, 2020; after the statutory deadline of January 31, 2020 for such taxpayer claims to be made per Statute 74.27(2)(b)5. Moved by Becker/Palmquist that we deny the claim of excessive assessment on the 2019 assessment on parcel #046-0200-02-000 owned by Sally Kraczek/Marge Mujwid (LE). No negative vote.

Quotes for upgrades to south entryway of town hall. Moved Becker/Palmquist to go with quote from J&J Stonework to replace the wooden ramp with a poured concrete ramp for \$2850. No negative vote. Board wants new quote from C&C Mowing Plus for the siding replacement and window installation as the concrete ramp may change that part of the job.

New Employee Manual: Board will review the handbook and bring suggested changes to the next meeting.

Public Comment: Jenn Harder, representing the Sumner Park Committee, stated that the new playground items the park committee recommended are difficult to purchase due to high demand. In the future she plans to purchase using her personal funds and request reimbursement from the Town.

Palmquist stated that 30<sup>th</sup> St south of US8 was patched by Monarch Paving per their agreement.

Suggested agenda items for next meeting: Employee Handbook, shouldering in Canton, upgrades to south entryway, consider 26 ½ Street petition by CSP Property Holdings, 2021 Budget.

Moved by Becker/Crotteau to approve the payment of bills covered with checks. No negative vote.

The next regular Town Board meeting is set for Tuesday, October 13, 2020 at 7:00 p.m. Meeting adjourned.
