## Town of Sumner Town Board Meeting Town Hall, 1550 24½ Street, Town of Sumner, Wisconsin Tuesday, July 13, 2021 at 7:00 p.m.

Meeting called to order by Town Board Chair Steven Palmquist. Present: Supervisors Steve Becker, Kevin Crotteau; Clerk Sandra Tomczak, Treasurer Jenn Harder, patrolman Cory Svoma.

Clerk verified proper public notice. Moved by Crotteau/Becker to approve the agenda. No negative vote. Reports given by Treasurer, Clerk and Patrolman. Moved by Becker/Crotteau to approve the May meeting minutes. No negative vote.

Public Comment. Stephanie Vincent: questions about 26th Street and why is mine using the south 1/2 of the road for daily traffic. Why not north 1/2 of road? Dave Mansfield asked about the low bid for maintenance gravel purchased this year.

Canton Park Committee progress report and requests. Joy Bartsch read the group's mission statement. After discussion, moved Becker/Crotteau to approve Resolution 2021-04 to open a new checking account for the Canton Park Committee. Motion carried without negative vote. Committee requested the Town commit to using up to \$50,000 of the ARPA grant for park water, sewer and a building. The board wishes to consider other funding uses for this grant, and will place this on the August meeting agenda.

Town Line Road agreements. Town of Doyle agreement: discussed addition of Sumner's maintenance of 28 1/2 St north of the town line in exchange for a yearly fee. Town of Stanley: addition of the 24th street drainage issue that verbal agreement, will ask the Stanley Town Clerk to write it up. Board wants to attend a Town of Strickland board meeting.

Patrolman requests to have spare tires on hand, spare tire rims and a steam pressure washer to be purchased this year. Board requested a list with prices.

Replacement of all or some town hall windows will be on the Agenda for August. Crotteau to obtain current window prices.

Informal Public Comment: Mansfield reports Sumner Community Foundation's balance is about \$1,700,000.

Suggested agenda items for next meeting: Canton Park Committee request for committment of \$50,000 of ARPA grant for park, 90-day review of patrolman's job performance/consider salary increase, patrolman request for equipment, tools, and supply inventory, review of 26th St Road agreement with Source Energy Services, replace windows in town hall, 2011 IH truck repair.

A report listing the bills paid by the alternative payment method and bills to be approved at this meeting was presented to the board. Moved Crotteau/Becker to approve these bills and a reimbursement to Joy Bartsch for park committee expense. No negative vote.
