

**Town of Sumner  
Town Board Meeting  
Town Hall, 1550 24½ Street, Town of Sumner, Wisconsin  
Tuesday, August 10, 2021 at 7:00 p.m.**

The meeting was called to order by Supervisor Steven Becker. Present: Supervisor Kevin Crotteau; Clerk Sandra Tomczak, Treasurer Jenn Harder and patrolman Cory Svoma.

Clerk verified proper public notice. Moved by Crotteau/Becker to approve the agenda. No negative vote. Reports given by Treasurer, Clerk and Patrolman. Moved by Crotteau/Becker to approve the July meeting minutes. No negative vote.

Public Comment. Carole Crisler: Persons walking or biking on public roads should wear visible clothes.

Canton Park Committee Progress Report: Donations of \$19, 586 have been raised to date. Still seeking a volunteer to draft a park layout so improvements are planned.

American Recovery Plan Act Funds Discussion: Will consider Chetek Ambulance Services request at the next meeting. Board will look into bonuses for town officials and staff.

Patolman Svoma 90-day job performance review: The board is pleased with Svoma's job performance and ideas to improve efficiency and reduce cost. Moved Crotteau/Becker to give Patrolman Svoma a \$1.50 raise to \$26.00 per hour and make retroactive to 90 days after hire. No negative vote.

Equipment for shop: Moved Crotteau/Becker to give Patrolman permission to get a welder and tank, not to exceed \$4000 from Praxair. No negative vote.

Review of the 26th St Road Agreement with CSP Property Holdings LLC reveals no specific date in the agreement for the annual payment of \$5000. The board will followup on this.

Town Hall window replacement: Moved Crotteau/Becker to order all new replacement windows for the hall, not to exceed \$8000. No negative vote.

Town Line Road agreements: Crotteau plans to attend a Town of Strickland board meeting. The 24th Street flooding mitagation will be part of Town of Stanley agreement. The Doyle agreement will include a short road going north into Doyle.

Repair of 2011 IH Truck coolant leak. Board advised Svoma take the truck into Meyers for diagnosis.

Public Comment: Lynette Buehler: the checking account for the Park Committee is set up.

Agenda items for future meetings: Park Committee progress report, Town Line Road agreements with Towns of Stanley, Strickland and Doyle, ARPA funds - Chetek Ambulance, changes to ATV-UTV ordinance to exclude dead-end roads.

A report listing the bills paid by the alternative payment method and bills to be approved at this meeting was presented to the board. Moved Crotteau/Becker to approve the bills. No negative vote.

The next regular Town Board meeting is set for Tuesday, September 14, 2021 at 7:00 p.m. Meeting adjourned.
