

**Town of Sumner
Town Board Meeting
Town Hall, 1550 24½ Street, Town of Sumner, Wisconsin
Tuesday, September 14, 2021 at 7:00 p.m.**

The meeting was called to order by Town Board Chair Steven Palmquist. Present: Supervisors Steve Becker, Kevin Crotteau; Clerk Sandra Tomczak, and patrolman Cory Svoma.

Clerk verified proper public notice. Moved by Crotteau/Becker to approve the agenda. No negative vote. Reports given by Patrolman, Clerk and Treasurer. Moved by Becker/Crotteau to approve the August meeting minutes. No negative vote.

Public Comment. Dale Crisler: several Canton properties are not well maintained.

Canton Park Committee members not in attendance.

American Recovery Plan Act funds discussion. Specific request from the Chetek Ambulance Service was discussed with Ryan, Director and Wayne Brenholt, board member. Mr. Brenholt stated he contacted the WTA and this is an acceptable use of ARPA funds. The board wants to set priorities and get more definite answers about other uses.

ATV/UTV damage on town road. Damage was on 13 1/2 Avenue and reported by Scott Tubbs. Crotteau will talk to the parents of the young person known to have caused the damage. Board suggested that in the letter sent with tax bills, taxpayers should be reminded of the town's ability to impose fines and recoup damages from persons that damage town roads.

ATV/UTV Ordinance can't be revised to forbid traffic on dead end roads.

Town line road agreements. Crotteau said he would set up a meeting with Strickland on the day after this meeting. Much discussion about possible fixes to 24th Street off County M (shared with Town of Stanley). It was suggested to attend a Town of Doyle board meeting to review that agreement.

Purchase quote from Monroe Truck Equipment for a new sander. Moved Crotteau/Becker to approve sander purchase for the quoted price of \$5690; not to exceed \$6,000 in case a new quote is needed. No negative vote.

Moved Becker/Crotteau to increase 2021 Budget Category, Equipment Outlay for new sander if necessary. No negative vote.

First draft of 2022 Budget. Paving projects may include 13 1/2 Ave, 1 mile. 14 3/4 Ave, 1 mile.

Suggested agenda items for next meeting: resolution to exceed the state-imposed levy limit for 2022.

A report listing the bills paid by the alternative payment method and bills to be approved at this meeting was presented to the board. Moved Crotteau/Becker to approve the bills. No negative vote.

The next regular Town Board meeting is set for Tuesday, October 12, 2021 at 7:00 p.m. Meeting adjourned.
