Town of Sumner- Town Board Meeting

Attendance: Steve Palmquist, Steve Becker, Mark Zimmer. **Others attending:** Clerk Sandra Tomczak, Treasurer Jenn Harder, Patrolman Cory Svoma. **Call to order:** Chairperson Palmquist. **Verification of proper public notice:** Clerk Tomczak. **Approval of Agenda:** Motion by Becker/Zimmer. Draft agreement between the Town and Chetek Area Ambulance Commission to provide ambulance service coverage south of US8. It was stated that the Foundation will pay the town and town will pay CAAC. The written agreement is not yet ready .

Cleanup Day Plans. Patrolman Svoma will arrange for rolloff rentals. Disposal cost at Barron County Waste-to-Energy shared. Svoma and Palmquist will work. Jenn Harder volunteered to check residency. Per an email from Sumner Community Foundation Chair Pannier, once their obligation to pay ½ of the truck cost is met, the foundation plans to pay for Cleanup Day. Board consensus not to charge any fees.

Wisconsin Towns Association district meeting. No one from Sumner will attend.

Attendance at Board of Review training. Clerk Tomczak will attend the April 28 training in Eau Claire.

Suggested agenda items for future meetings: Tim Gerber of Cameron Bank to speak to board about options to lease equipment, Plan Commission Appointments, 3-year road plan, CAAC agreement.

A report listing bills paid by the alternative payment method and bills to be approved at this meeting was presented to the board. Moved Becker/Zimmer to approve the bills. No negative vote.
