Verification of prop<sup>7</sup>er public notice: Clerk Tomczak

Approval of Agenda by Board: Moved Zimmer/Tubbs to approve. No negative vote. Reports and Correspondence: Treasurer submitted a written reconciliation report; Clerk reported on elections, went well except for the level of noise in the hall when many voters are in building, also very cramped for space, a hall large enough for the public to use would be desirable when the payout formula from the foundation is changed. F350 truck transmission repair: Svoma will take pickup truck to Rice Lake Diesel for an engine diagnostic.

Portable toilet purchase and pumping service. Move Zimmer/Tubbs to buy portable toilet for \$2000 from Jiffy Biffy and have Jiffy Biffy do the pumping. No negative vote.

Clerk appointment, 2 year term beginning April 16, 2024. Moved Zimmer/Tubbs. No negative vote.

Treasurer appointment, 2 year term beginning April 16, 2024. Moved Tubbs/Zimmer. No negative vote.

Culvert/driveway ordinance. Clerk provided guidance and samples to the board.

Upgrades to ball park lighting and Canton street lighting. Palmquist reported Xcel Energy is likely not charging much to upgrade the electrical service.

Items intended for future meetings. Budget numbers from County Highway Department to act on, culvert/driveway ordinance, F350 engine repair, ball park lighting upgrades, re-keying locks on buildings, possibly new doors.
