- 1. <u>Call to order</u>: Chair Palmquist. Supervisors Zimmer and Tubbs attending.
- 2. Pledge of Allegiance: Recited
- 3. <u>Verification of proper public notice</u>. Clerk Tomczak
- 4. Approval of Agenda by Board. Moved Tubbs/Zimmer to approve. No negative vote.
- 5. <u>Reports and Correspondence:</u> Treasurer gave reconciliation report; Clerk reported on election activity for the month of Oct and election day, Town of Sumner selected for post-election voting equipment audit, current budget report; Patrolman bridge on 27<sup>th</sup> St done, grading roads.

- 8. <u>Installation of security cameras at the Canton Park.</u> This request from the park committee includes cameras for the Sumner cemeteries also. About \$140 for a camera, \$9 monthly subscription or 12 month unlimited per camera for uploads to a cell phone. An estimate for full cost is needed. WTA will be contacted about any legal issues.
- 9. <u>Annual Town celebration, Canton Park Committee requests board set aside \$5000 for the purpose</u>. Moved Tubbs/Zimmer that board set aside \$5000 for the purpose of an annual town celebration. No negative vote.
- 10. <u>Designate a new town bank account to set aside funds for a well at the Canton park</u>. The park committee has received donations toward putting in a well at the park. Moved Zimmer/Tubbs that the clerk set up a line item in the town's accounts to track donations for a well. No negative vote.
- 11. <u>Project on 15 1/2-16th Ave, Old 14.</u> Zimmer reported 2024 work is done, still waiting for bill from HAAS Construction.
- 12. 27<sup>th</sup> Street project south of US 8 Shoulder is now done. 2024 work completed.
- 13. Repairs to bridge P-03-84 on 27<sup>th</sup> St just north of 17<sup>th</sup> Ave intersection. Planned 2024 work on the bridge is complete.
- 14. 2-year road plan discussed.
- 15. <u>2025 Budget discussion and possible approval.</u> Moved Zimmer/Tubbs to approve the 2025 Budget. No negative vote.
